This Operational Directive (OD) describes the critical requirements and processes to be followed when working on this special project.

The project will address the personal development, training, and employment needs of California's justice-involved and formerly-incarcerated populations.

Population(s) to be Served:

- Justice-Involved Individuals (adults and juveniles) who are on parole, probation, mandatory supervision, post-release community supervision, or are otherwise part of the supervised population and/or under the jurisdiction of a county or the California Department of Corrections and Rehabilitation. This also includes individuals who are on county informal probation, county deferred entry of judgement, or any other county diversion program such as drug courts, veterans courts, community courts or other specialty courts.
- Formerly-Incarcerated Individuals who have at any time served a custody sentence in any adult or juvenile federal, state, or local detention facility; or in any alternative custody program such as home detention

Eligibility Criteria:

- Meets one or more of the populations listed above
- 18 years of age or older
