The meeting was called to order at 4:00 p.m., quorum established at 4:09 p.m.

COMMENTS BY FRWDB CHAIR AND/OR EXECUTIVE STAFF:

Blake Konczal, Executive Director, Fresno Regional Workforce Development Board (FRWDB), reported that the FRWDB, in partnership with State Center Community College District, received an additional assistance grant from the Governor's office to serve former Bitwise employees. There will be press event on September 19, 2023, at 10:00 a.m. at the Bitwise Reemployment Center. Mr. Konczal thanked Director Tarver for her assistance with receiving the grant.

Item Description/Action Taken

6. Meeting of the Minds Update

Mr. Konczal shared that the California Workforce Association's (CWA's) Meeting of the Minds (MMM) conference was held last week in Monterey. He stated that the FRWDB was well-represented with six (6) presentations: Uncharted Territory, where it was shared about the FRWDB's efforts to expand its Forestry program; Al: Reshaping California's Employment Landscape; Real Referrals Get Real Results, where it was shared about the FRWDB's referral network; From Tech to Tumble, about Bitwise and the FRWDB's Rapid Response efforts; Get it Done, which was about how to open a new One-Stop on time and under budget; and You Can't Build America Without ERiCA, which was about creating and expanding equal representation in the construction trades.

Director Avila arrived (4:09 p.m.) QUORUM ESTABLISHED

Mr. Konczal stated that the number of FRWDB presentations that were accepted and that were well attended showed that the FRWDB was considered a premier workforce board amongst its peers and that people were genuinely interested in what the FRWDB was doing. He added that colleagues from other parts of the state have asked for FRWDB staff to do presentations and that there are key areas, such as construction and forestry, that FRWDB was looked at as being preeminent.

Director Blunt, who presented at MMM, shared that the FRWDB led by example in a relationship-driven industry and that the FRWDB should be proud.

Martha Espinosa, Marketing and Grants Manager, FRWDB, shared that the FRWDB hosted a networking event during the conference called Great Leaders of Workforce and that it provided a great opportunity to make connections and showcase the FRWDB.

This was an information item.

Director Karbassi arrived (4:15 p.m.)

7. In the Community – Marketing Update

Ms. Espinosa provided highlights of the marketing activities and events that occurred since the last FRWDB meeting and shared videos highlighting two (2) participants' success: Brandon Cubit, who obtained employment as a Porter with Crunch Fitness; and Celeste Gomez, who obtained a position as Final Finish Carpenter with The Alvarado Group. Ms. Espinosa noted that Ms. Gomez was a graduate of the second (2nd) cohort of the Valley Build NOW program.

Chair Montalbano commented that the videos were excellent and done professionally. He asked if FRWDB was cataloging these videos so that, in four (4) or five (5) years, staff could contact participants who were showcased in the videos and find out what they are doing professionally at that time. Ms. Espinosa indicated that the names were recorded and that staff could look into following up on participants' contact information for this purpose.

Ms. Espinosa mentioned that in addition to sharing participant success stories, another goal was to help brand who the FRWDB was and what they do. She handed out Fresno Workforce Connection ball caps to the Directors to wear as they go into the community.

Ms. Espinosa shared about some recent FRWDB-sponsored events:

<u>Father Fest:</u> On June 10th, the FRWDB held this event to promote its Fatherhood program. There were several demonstrations, including how to tie a tie, how to change a tire, and how to change a diaper. There were about 150 people who attended.

<u>Bitwise Job Fair:</u> On June 16th, the FRWDB partnered with the City of Fresno to hold a job fair focused on former Bitwise employees. The event was planned in less than two (2) weeks, but was still a great success with over 300 registered participants and 61 businesses/employers participating.

<u>Valley Build NOW Graduation:</u> June 30th, the FRWDB held a graduation for the second (2nd) cohort of the all-women construction cohort. There were 15 graduates. "NOW" stands for Non-Traditional Occupations for Women. Ms. Espinosa shared a video clip of the graduation when one of the graduates, Marianne Reyes, spoke. Ms. Reyes shared her story of losing her home during economic turmoil in Venezuela and then coming to the US and enrolling in the Valley Build NOW program. She received a standing ovation.

New Site Opening and Job Fair: On July 12th, the FRWDB held the grand opening of its Dislocated Worker job center, along with a job fair. Over 500 attendees and over 30 businesses/employers participated. It was a successful event.

Ms. Espinosa spoke about the FRWDB's presence on social media, stating that they are on Facebook, Instagram and Twitter and that they try to post all flyers in both English and Spanish. She indicated that FRWDB would be doing monthly Facebook Live events with B95 and La Preciosa, and that they would also be doing Youtube ads throughout Fresno County, including targeted ads on the west side of the County.

She reported that the FRWDB renewed its contracts with B95 and La Preciosa and said that a lot of FRWDB training program graduates have heard about the programs on the radio. Another outreach activity the FRWDB has been doing on a quarterly basis with some smaller, rural areas was sending flyers out with residents' water bills. Last quarter, 750 flyers were sent out in San Joaquin, 1,800 in Firebaugh and 2,000 in Mendota.

Ms. Espinosa shared about some upcoming events: A Bitwise press event on September 19th, Valley Build graduation in November (more information to come as details are finalized), and the FRWDB Christmas Mixer on December 6th.

Ms. Espinosa then shared some goals for the new Program Year:

<u>Participant Flow Project</u>: FRWDB staff created a 12-video series to help better understand the experience for participants who receive Workforce services. A beta version of the videos has been completed and now the videos will be shot professionally.

<u>Billboards:</u> Ms. Espinosa met with Outfront, one (1) of the country's leaders of outdoor advertising. She indicated that having billboards in Fresno's rural communities would be a great way for the FRWDB to get its message out.

<u>Job Fairs:</u> The FRWDB planned to host three (3) job fairs per year: one (1) for the east side, one (1) for the west side, and one (1) for the metro area.

<u>Website:</u> Discussions to update the FRWDB's website have begun, as an update has been needed to keep up with the times.

Ms. Espinosa thanked the Directors and expressed her appreciation for them attending FRWDB-sponsored events, stating that their presence added legitimacy to the events.

8. Approval of the June 7, 2023, Meeting Minutes

BONNER/OLIVARES – APPROVED THE JUNE 7, 2023, MEETING MINUTES. (UNANIMOUS)

9. July 2023 Financial Report

Mr. Konczal presented the July 2023, Financial Report for the FRWDB's acceptance. He called attention to the third column on the Report to provide clarification that those amounts represented money that crossed over fiscal years, and said that this was a sign of a competitive program.

Director Olivares asked about the unspent amount for the High Roads Construction Careers grant, and would it be expended by the term date. Mr. Konczal explained that this grant, among others, went live when the COVID pandemic hit, at which time it was nearly impossible to recruit individuals for the program. The state will be granting an extension of this grant after September 30, 2023, so the new term date was not yet reflected on the Report.

Director Olivares then asked if it was the same situation for GRID Alternatives. Mr. Konczal called FRWDB's Senior Deputy Director, Phyllis Stogbauer, to the table to answer Director Olivares' question. Ms. Stogbauer explained that GRID Alternatives was a solar company that received a grant from the Department of Labor. They subcontracted with FRWDB and the Madera Workforce Board to provide supportive services. GRID Alternatives projected more for supportive services than what had actually been needed, so they were working with their funder to move funds around to where there was a greater need.

OLIVARES/BONNER – ACCEPTED THE JULY 2023 FINANCIAL REPORT. (UNANIMOUS)

10. Government Update

Diane Jensen, Government Relations Coordinator, FRWDB, provided an overview of the FRWDB's government outreach efforts, some of the legislation she had been tracking, and introduced the Directors to the software she used to track legislation.

Ms. Jensen stated that in 2022, the FRWDB started its City Council Tour. The purpose of the Tour was to share information about the FRWDB and the services they provide so that constituents could be referred to the FRWDB, should a need arise. Since starting in 2022, they have visited Firebaugh, Parlier, Reedley, Mendota, San Joaquin and Kerman. They will be attending the Selma City Council within the next week. They had also started visiting representatives for the districts within Fresno County, and will soon start visiting with district representatives for the City of Fresno and the City of Clovis. Plans are to complete the City Council Tour in 2024, when Ms. Jensen will begin visiting school boards throughout Fresno County.

Ms. Jensen shared that she frequently used two (2) features of a software called Policy Engage: Track Bill and Flash Mention.

Track Bill sends an update to Ms. Jensen daily showing bills that were just released on the state and federal level, and which bills had had activity on them. She noted that there were 21 bills she was currently tracking that could affect workforce in some way. She stated that this feature also helped with analysis by providing a quick summary that gets to the "meat" of the bill.

The second feature, Flash Mention, allows Ms. Jensen to identify specific key words and every time those words were mentioned on the news, the radio or social media, she received a notification.

Ms. Jensen shared that the state legislature would be adjourning the next day and that the Governor had until October 14th to either pass or veto the bills.

Mr. Konczal stated that having Ms. Jensen in this position was really important and that as she monitors legislation, if something is identified that may significantly impact the FRWDB, FRWDB staff can bring it to the FRWDB as soon as possible.

This was an information item.

11. Recognition of Board Anniversaries

Chair Montalbano recognized Directors for their years of service on the FRWDB with a presentation of certificates. He recognized Directors whose anniversaries occurred in the months of July through September: Scott Miller – nine (9) years; Joe Olivares – 18 years; and Jeff Hensley – 19 years. Mr. Konczal then presented Chair Montalbano with a certificate recognizing his 19th year on the FRWDB.

Chair Montalbano introduced new FRWDB Director, Rodney Branch, and asked him to share a little about himself. Director Branch shared that he had over 30 years in education and was currently the Principal of Fresno Adult School, where they serve adults who were working towards obtaining a High School Diploma. He stated that he was happy to be on the FRWDB and doing work for the community.

This was an information item.

12. Scholarship Panel Sign Ups

Director Blunt shared about FRWDB Scholarship Panels and the impact of the award on the recipient, and what a great experience it was for the Panel members, as well. He distributed a sign-up sheet and encouraged Directors to pick a date to serve on a panel, if they were able. He asked Jose Espinoza, Training Manager, FRWDB, to share about the Scholarship Panel process.

Director Blunt also distributed copies of a letter he and Mr. Espinoza recently received from a scholarship recipient, expressing their appreciation for their scholarship. He indicated that the FRWDB awards approximately 400 scholarships a year.

This was a discussion item.

13. FAWIC Job Openings

Director Blunt shared that the FAWIC (Fresno Area Workforce Investment Corporation) had a job opening for a Monitoring Coordinator. He indicated that Ms. Espinosa had just emailed the Directors a shareable post of the job opening and he asked the Directors to forward the job posting to three (3) individuals in their network.

This was a discussion item.

14. Information Sharing

Director Sotiropoulos shared that the Fresno Greek Fest was coming up the next weekend and stated that it is a great community event. He offered admission tickets for the event to the FRWDB.

This was a discussion item.

15. Agenda Items for December 6, 2023, Meeting

There were no items recommended for the December 6, 2023, FRWDB meeting agenda.

16. Meeting Feedback

No meeting feedback was provided.

RECOMMENDATION:

Accept the Fresno Regional Workforce Development Board (FRWDB) October 2023 Financial Report.

REASON FOR RECOMMENDATION:

The attached summary financial report and charts display year-to-date financial information through October 31, 2023.

- Transformative Climate Communities (TCC): This grant ends March 31, 2024; it is 41.32% expended at \$516,322 with an unspent amount of \$733,110. FRWDB staff requested a one (1)-year no-cost extension to March 31, 2025.
- 2020 September Wildfires: This grant ends December 31, 2023; it is 62.97% expended at \$188,900 with an unspent amount of \$111,100; the final cohort has been scheduled during the last three (3) months of the grant (October 2023 December 2023).
- Equity and Special Populations (ESP): This grant ends December 31, 2023; it is 60.41% expended at \$453,077 with an unspent amount of \$296,923. FRWDB was granted a three (3)-month no-cost extension to March 31, 2024.
- City of Fresno One Youth Job Corps: This grant ends May 1, 2024; it is 44.31% expended at \$287,461 with an unspent amount of \$361,219. On June 29, 2023, FRWDB received an increase in funds of \$367,130 making the total grant amount \$648,680.
- Pathway Home Grant GRID Alternatives: This grant ends on December 31, 2023; it is 6.92% expended at \$5,097 with an unspent amount of \$68,533. FRWDB staff does not anticipate fully expending this grant because the Fiscal Agent (GRID Alternatives) has not had the participant referrals as initially intended.
- Staff has no concerns with other grant expenditures at this time.
