SUBJECT: Authorization of Executive Director to Approve Procurement Award

### **RECOMMENDATION:**

Authorize the Fresno Regional Workforce Development Board (FRWDB) Executive Director to approve the procurement award of a Forestry Technician and Heavy Equipment training contractor, in an amount not to exceed up \$124,999.00.

#### **REASON FOR RECOMMENDATION:**

FRWDB staff was recently notified that due to a shortage of instructors, the designated trainer for the Central Valley Forestry Corps training program was not available to provide training for the Spring 2023 cohort, which is scheduled to begin at the end of March. In order to have a training provider in place in time to start the March cohort as scheduled, FRWDB staff began a procurement process to identify and award a contract to a training provider prior to the March 2023 training start date.

To allow for the expedited turnaround required to secure a training contractor, FRWDB staff is requesting that the Executive Committee authorize the FRWDB Executive Director to approve the procurement award recommendation.

Results from procurement activities will be presented at the Executive Committee in April 2023.
