1. May 15, 2025, Youth Council Meeting Minutes

Blake Konczal, Executive Director, Fresno Regional Workforce Development Board (FRWDB), presented the May 15, 2025, meeting minutes for the Youth Council's (Council's) approval, or correction and approval.

MADDEN/TUTUNJIAN – APPROVED THE MAY 15, 2025, YOUTH COUNCIL MEETING MINUTES. (UNANIMOUS)

2. Youth Program Success Stories

Martha Espinosa, Deputy Director Marketing, Grants and Business Initiatives, FRWDB, shared the success stories of FRWDB's First Quarter Business of Excellence and First Quarter Youth Achievement Award winners.

The Business of Excellence Award winner was Ranch Market in Sanger. Ms. Espinosa shared that this business had gone above and beyond to create meaningful opportunities for young adults. Over the past 12 months, Ranch Market had hosted six (6) youth Work Experience opportunities and made two (2) hires. Ms. Espinosa presented a video, showcasing Ranch Market.

Council Member Engel-Silva arrived (4:08 p.m.)

The Youth Achievement Award winner for the First Quarter was Ricardo De La Rosa. Ms. Espinosa shared that Mr. De La Rosa is a remarkable young adult whose story embodied perseverance, dedication, and the transformative impact of Workforce Connection's Young Adult programs. Mr. De La Rosa completed a nine (9)-month intensive Heating, Ventilation, and Air Conditioning (HVAC) training at Institute of Technology and was hired as an HVAC Technician with California Climate Pros. Ms. Espinosa shared a video highlighting Mr. De La Rosa's story.

Ms. Espinosa noted that FRWDB had been utilizing these types of success stories in its marketing efforts and outreach.

This was an information item.

3. Student Training and Employment Program Year Three Contract Award

Maricela Diaz, Youth Program Manager, FRWDB, presented for the Council's recommendation for FRWDB approval, \$611,329.42 in award allocations for the third-year funding of the Student Training and Employment Program (STEP) grant. This funding was awarded by the California Department of Rehabilitation and the Foundation for California Community Colleges for the period of January 1, 2026, through December 31, 2026. Award allocations were detailed in the agenda item, with America Works being awarded \$88,042.54 for program oversight.

Ms. Diaz stated that the STEP program aims to strengthen partnerships with key stakeholders in the region who support students with disabilities (SWDs) by maintaining open referral pathways and improving access to services. The program would provide work experience, job preparation training, job exploration and postsecondary counseling, and self-advocacy training for SWDs.

Council Member Martindale asked the age of the individuals who would be served through this grant. Nuvia Varela, Program Manager with America Works, stated it was youth aged 16 to 21 with a known disability. Council Member Buttles asked how many students would be served. Ms. Varela indicated that 154 were served in years one and two of the grant, and another 64 would be served under the year three contract. Council Member Martindale asked if performance for previous years could be included in future agenda items of this nature. Mr. Konczal indicated that FRWDB staff would include that information in the future and would also bring quarterly performance reports to the Council for formula and grant funding.

MARTINDALE/WATSON – RECOMMENDED THAT THE FRWDB APPROVE THE STUDENT TRAINING AND EMPLOYMENT PROGRAM YEAR THREE CONTRACT AWARD. (UNANIMOUS)

4. Ratification of New Youth Council Member

Mr. Konczal presented for the Council's recommendation for FRWDB approval, the ratification of Erin Evans to the Youth Council. Ms. Evans is the Associate Director Human Resources at the California Teaching Fellows Foundation.

MADDEN/METTERS – RECOMMENDED THAT THE FRWDB RATIFY ERIN EVANS AS A NEW YOUTH COUNCIL MEMBER. (UNANIMOUS)

5. **Consent Items 5A – 5D**

Council Member Martindale pulled Consent Item 5D for discussion.

TUTUNJIAN/ MADDEN – APPROVED CONSENT ITEMS 5A THROUGH 5C. (UNANIMOUS)

Item 5D: Local Performance Results Report

Ms. Diaz presented the First Quarter Program Year (PY) 2025–2026 Youth Program Providers of Services Local Performance Results Report for FRWDB approval. Council Member Martindale noted prior challenges with the Rural West area being under-served and referenced the report showing in-school youth in the area remained under-served. She asked what steps were needed to help FRWDB meet its goals for this community. Mr. Konczal explained that the in-school youth goal for Rural West represents just under two percent (2%) of FRWDB's overall youth service goal. Ms. Varela reported that America Works and FRWDB continue outreach efforts to engage out-of-school youth in the area, while Ms. Espinosa described the marketing strategies being used. Phyllis Stogbauer, Senior Deputy Director, FRWDB, stated that securing office space in Coalinga for a consistent staff presence one (1) to two (2) days per week would be key to reaching out-of-school youth. Council Member Martindale offered to identify office space for provider staff, and Ms. Stogbauer indicated she would follow up to obtain the contact information.

Mr. Konczal stated that it was important to focus on enrollment in the Rural West, but that after all the efforts to increase enrollments in this area, the FRWDB may decide to move the funding to another area where young adults could be served, in which case FRWDB staff would bring an item to the Council to discuss and make recommendations on reallocation of funding.

MARTINDALE/METTERS – APPROVED CONSENT ITEM 5D. (UNANIMOUS)

6. **Youth Demographics Report**

Ms. Stogbauer presented the First Quarter PY 2025-2026 Youth Demographics Reports for the Council's review. She noted that there was very little change from the previous quarter's reports. There were no questions from the Council.

This was an information item.

7. **Agenda Items for February 19, 2026, Meeting**

Mr. Konczal indicated that the following items would be brought to the Council for recommendation at its February 19, 2026, meeting:

1) A policy recommendation that deals with how funding should be directed when an area is not meeting goals, and 2) FRWDB staff will provide a more detailed report about marketing efforts taken to increase enrollments in the Rural West.

Council Member Tutunjian requested that FRWDB staff bring an information item showing the STEP grant's performance over the past two (2) years.

SUBJECT: ValleyBuild Earmark Grant Contract Awards

RECOMMENDATION:

Recommend that the Fresno Regional Workforce Development Board (FRWDB) approve the reallocation of ValleyBuild Earmark Grant funds, State Budget Earmark passthrough by the California Workforce Development Board, as outlined below.

REASON FOR RECOMMENDATION:

Through this modification, revised costs for proper billing and internal record keeping will be updated. ValleyBuild will be able to continue to meet contractual goals and increase overall growth and success of the program.

As this grant has been extended by six (6) months, to June 30, 2026, this recommended modification supports ValleyBuild by adding capacity to staffing, training, equipment and outreach funds to support the four (4) ValleyBuild cohorts scheduled in Fresno, Madera and Tulare. These cohorts are scheduled for March 2026 through June 2026. In addition, this modification would increase funding to Central Valley Pipe Trades to support an additional cohort in the Modesto region.

Recommend that the Fresno Regional Workforce Development Board (FRWDB) accept the Young Adult Program Satisfaction Report for the Second Quarter of Program Year (PY) 2025-2026.

REASON FOR RECOMMENDATION:

The Fresno Regional Workforce Development Board (FRWDB) Joint Powers Agreement states, in part, that FRWDB staff shall fulfill administrative responsibilities as set forth in the Workforce Innovation and Opportunity Act (WIOA). These responsibilities include administering programs as described in the WIOA, developing budget plans, and carrying out additional administrative duties such as assessing performance and evaluating the benefit, productivity, and impact of all programs funded under the WIOA, as amended or superseded. FRWDB staff are also responsible for submitting progress reports to the appropriate governing bodies.

As part of these responsibilities, FRWDB staff have implemented the Young Adult Program Satisfaction process and data collection system. Subcontracted service providers submit youth satisfaction data to FRWDB staff on a monthly basis. The data is then aggregated, analyzed, and reviewed quarterly, and the findings are presented to this Council for review.

To further strengthen this process, FRWDB staff have introduced a new electronic satisfaction survey to enhance data accuracy, accessibility, and response rates among youth participants. The transition to this digital format will streamline data collection and enable more timely and comprehensive analysis of participant feedback.

The Second Quarter Young Adult Satisfaction Survey Report for PY 2025–2026 is attached for your review.

FRWDB staff continue to collaborate with service providers to improve processes that enhance young adult participant satisfaction. These improvements are based on data collected through satisfaction surveys, monitoring reviews, complaints, and monthly operations meetings between providers and FRWDB staff.

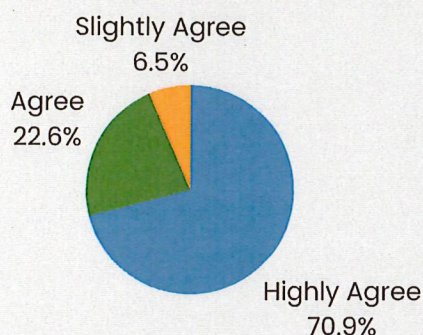
2025-2026 Quarter 2 Customer Satisfaction Survey

2025-2026 QUARTER 2 CUSTOMER SATISFACTION SURVEY

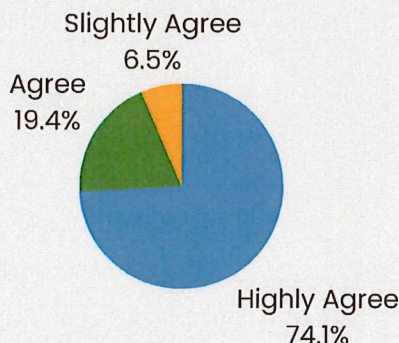

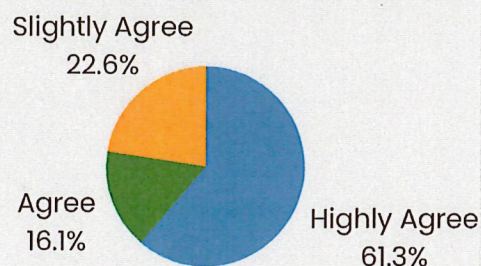

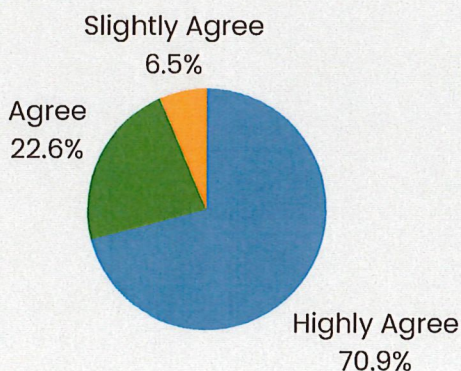

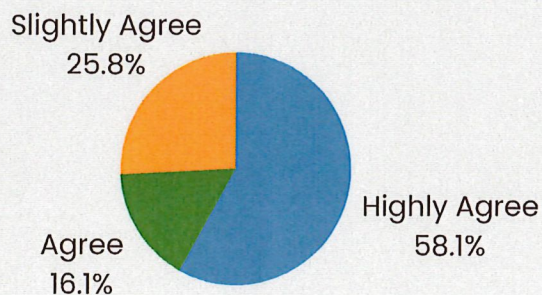

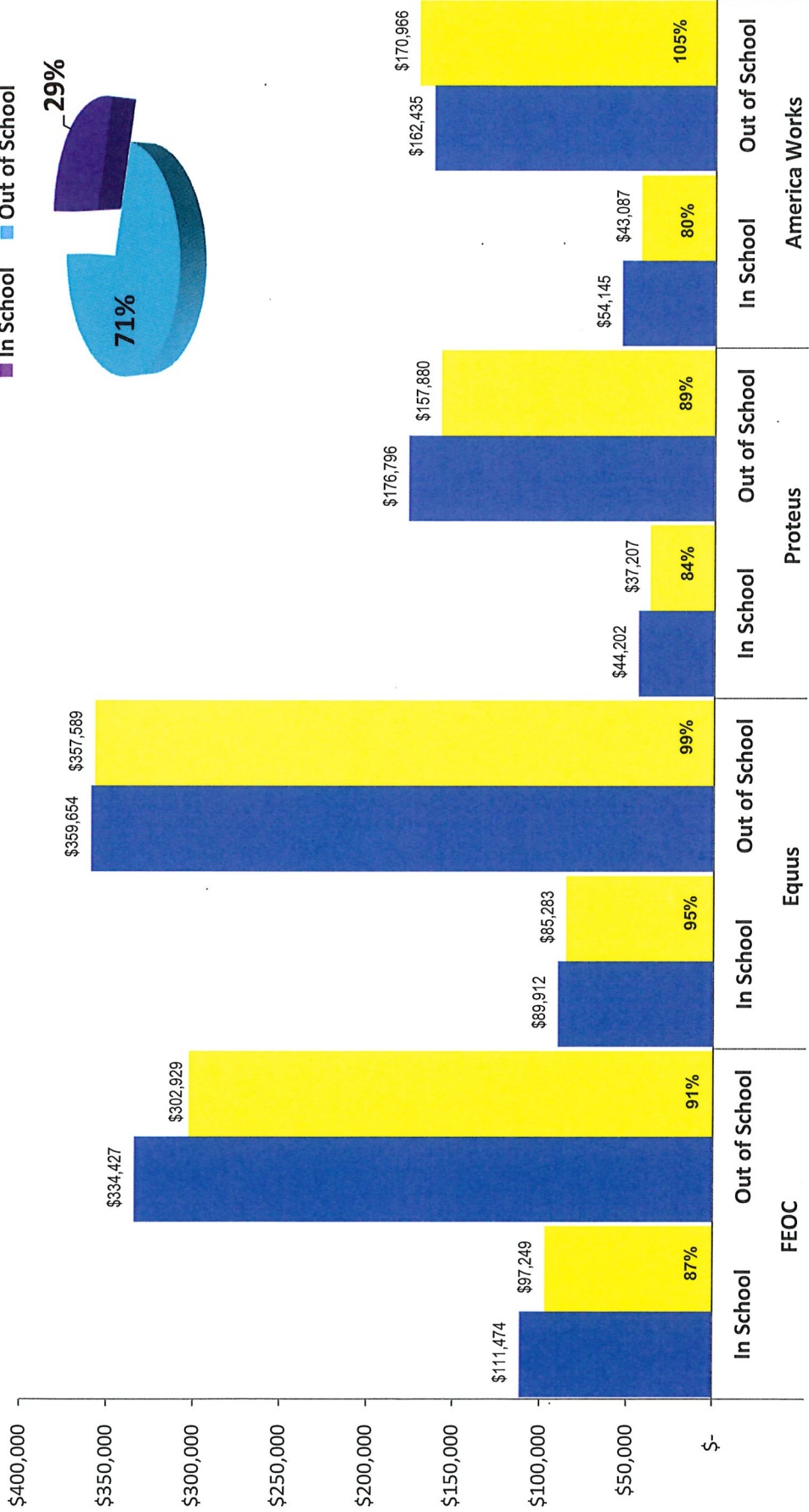

Total Expenditures



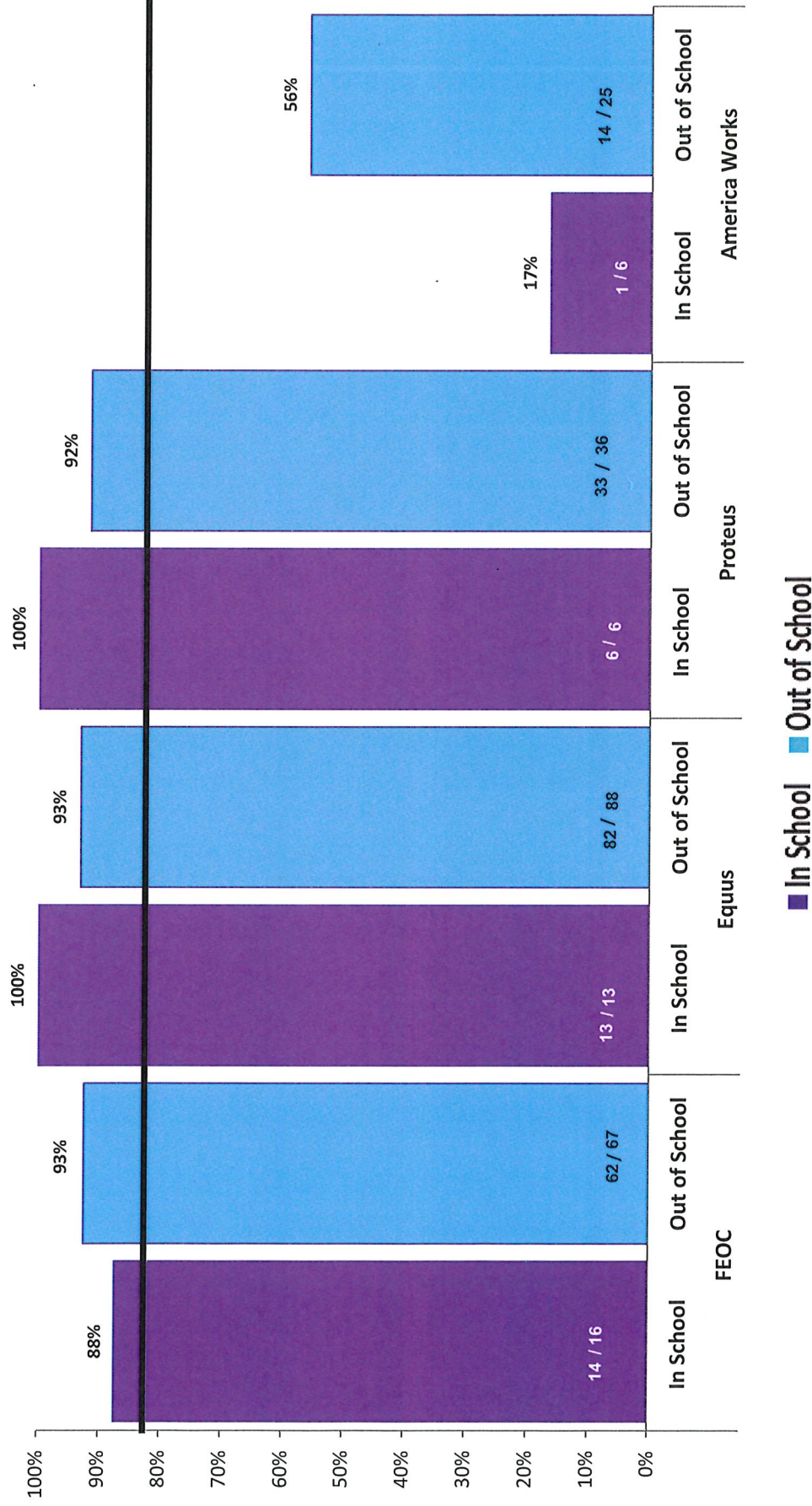

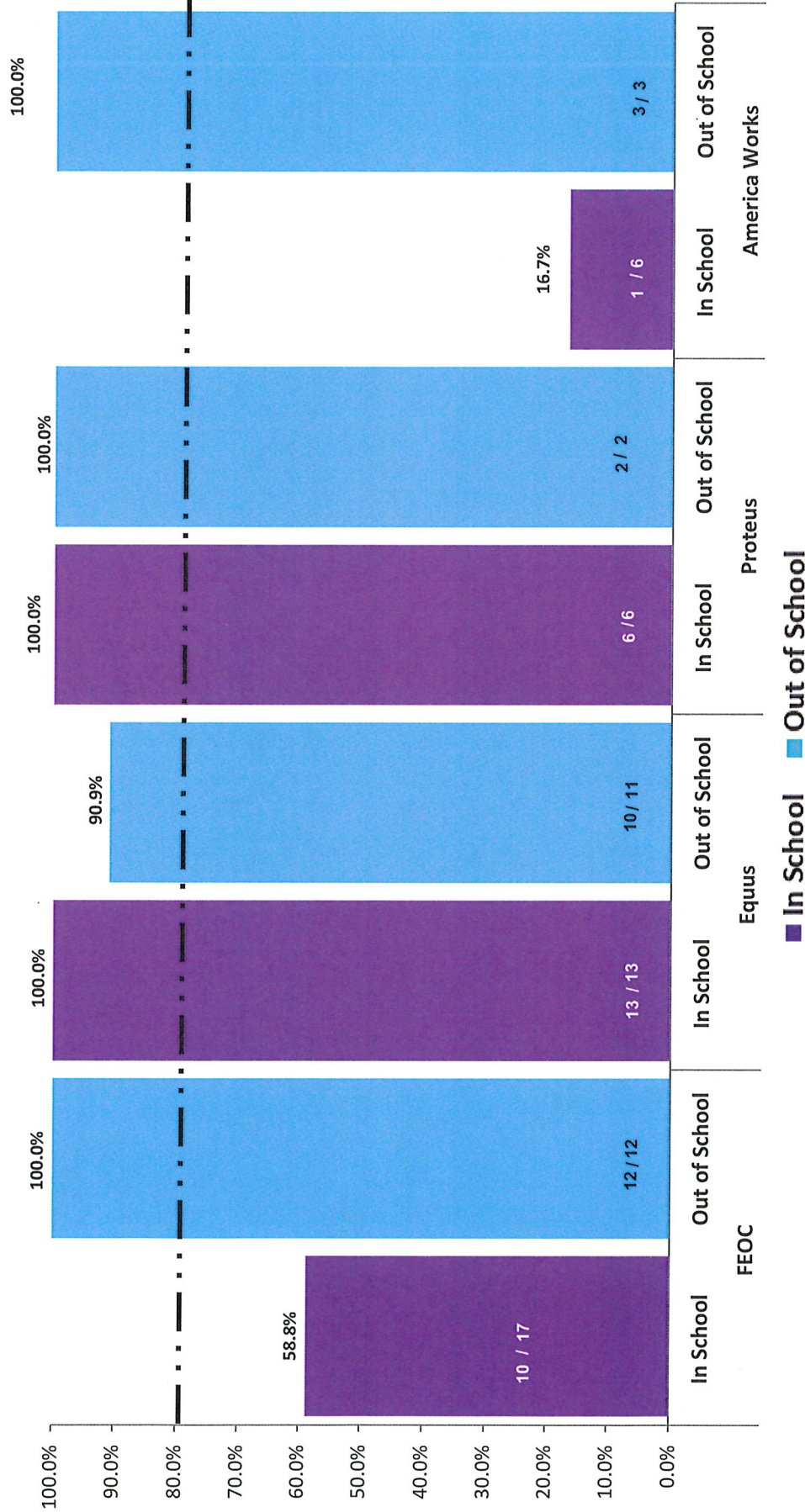

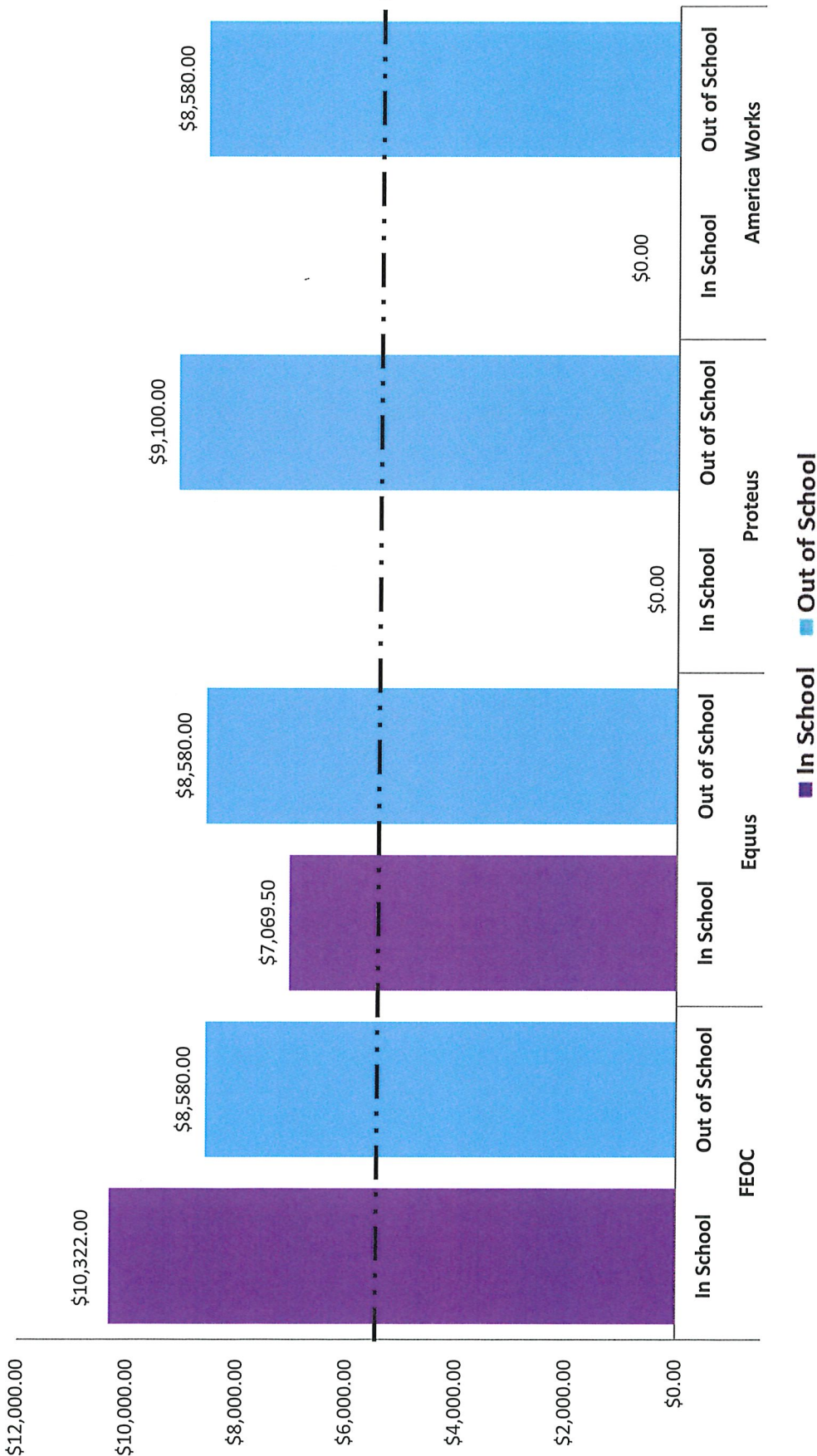

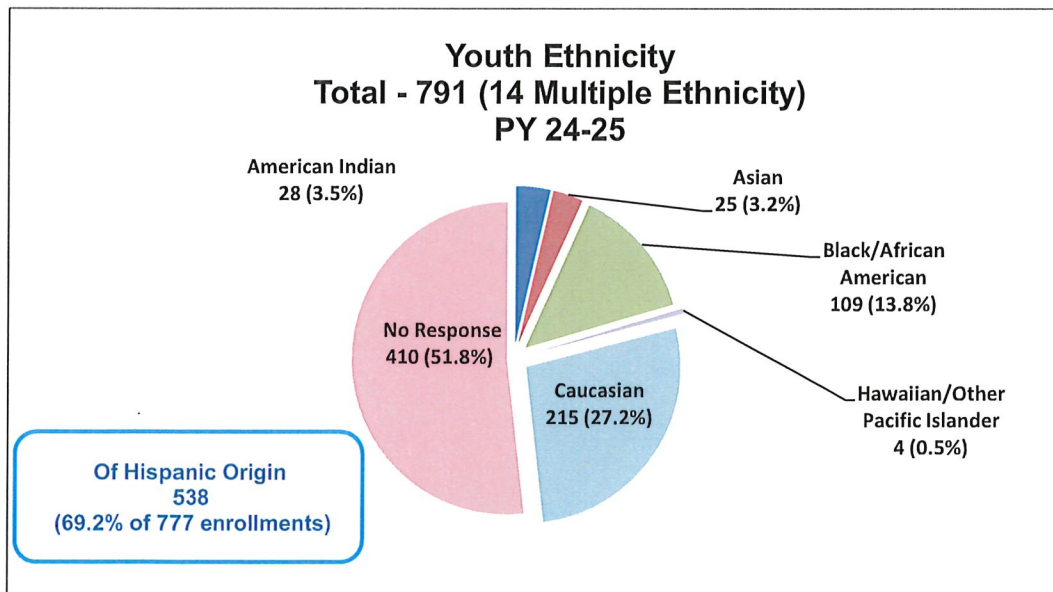
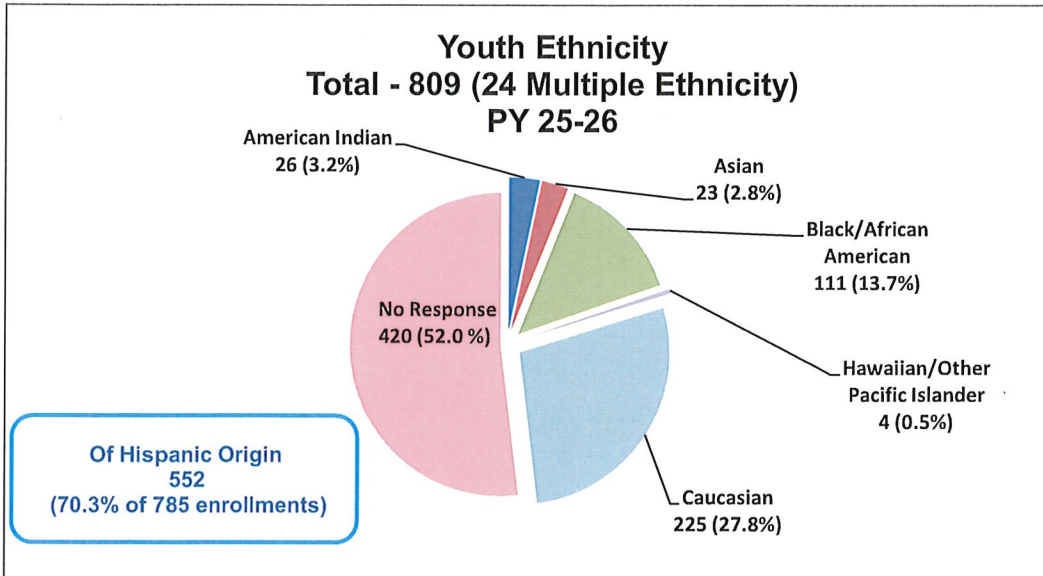
Young Adult Demographics – Second Quarter, Program Year 2025–2026



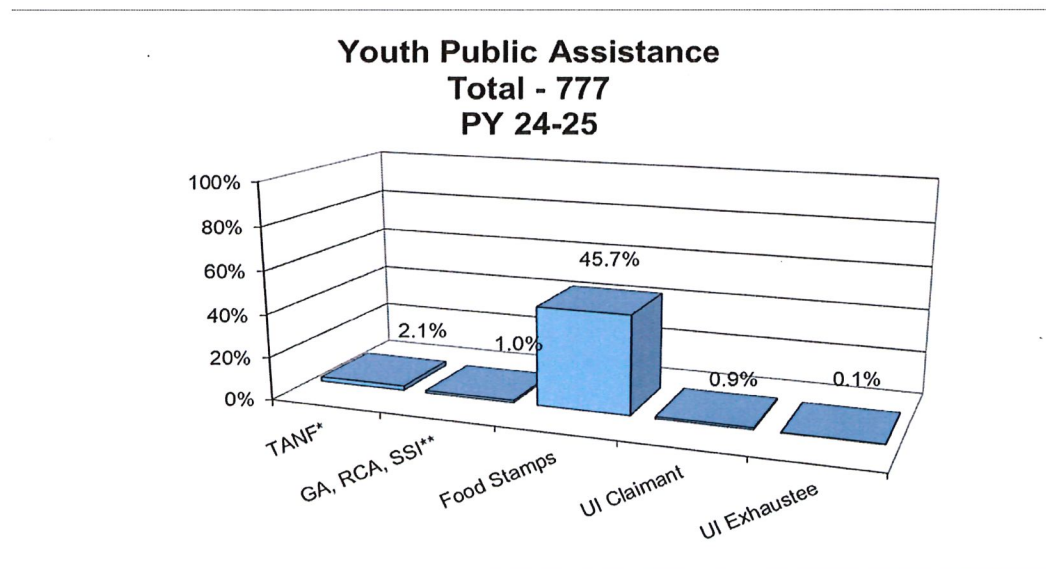
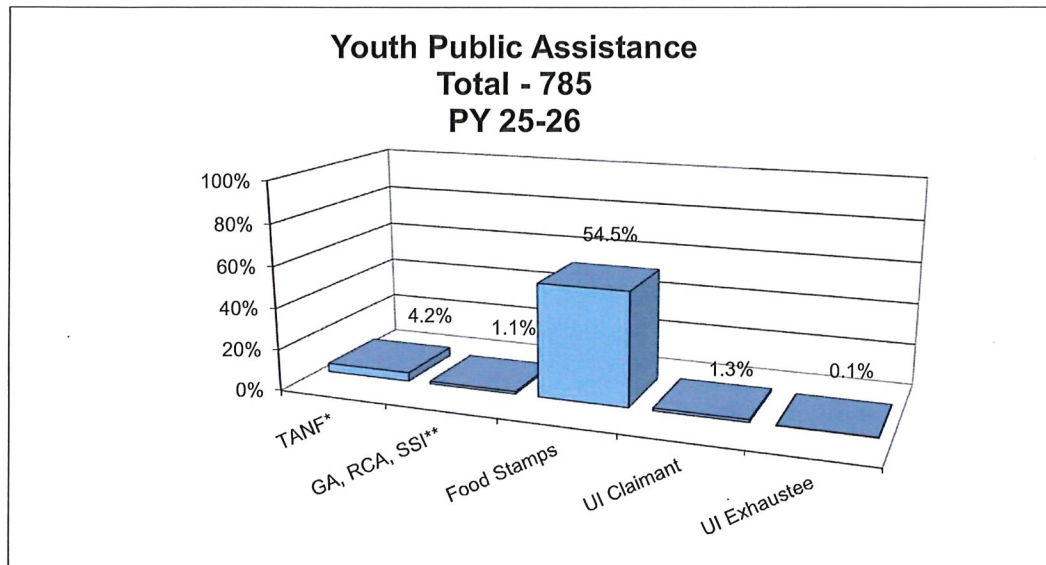
Young Adult Demographics Second Quarter, Program Year 2025-2026

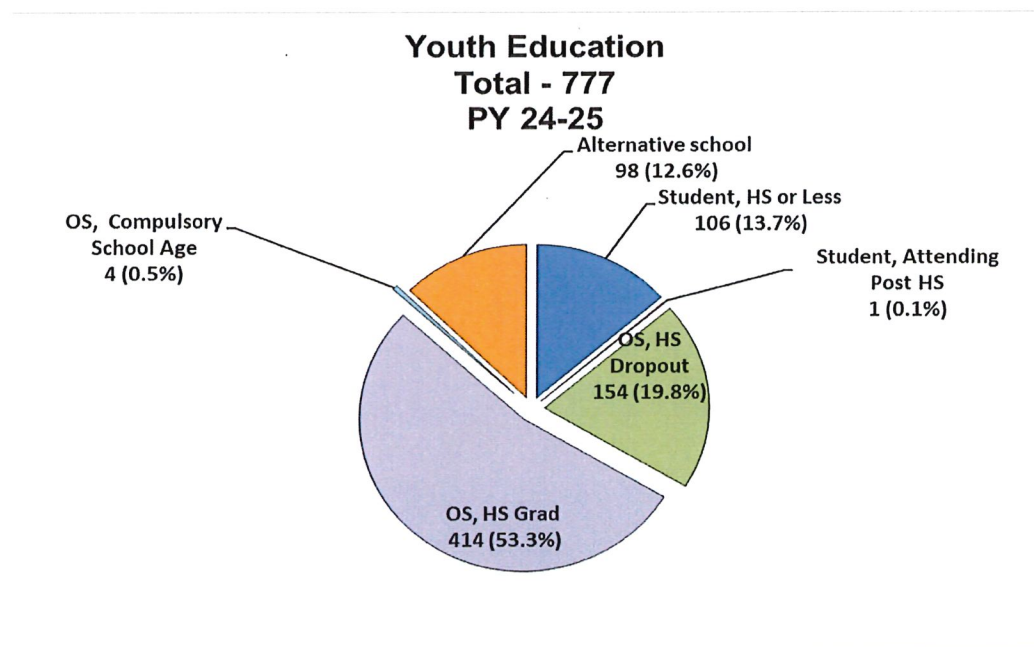
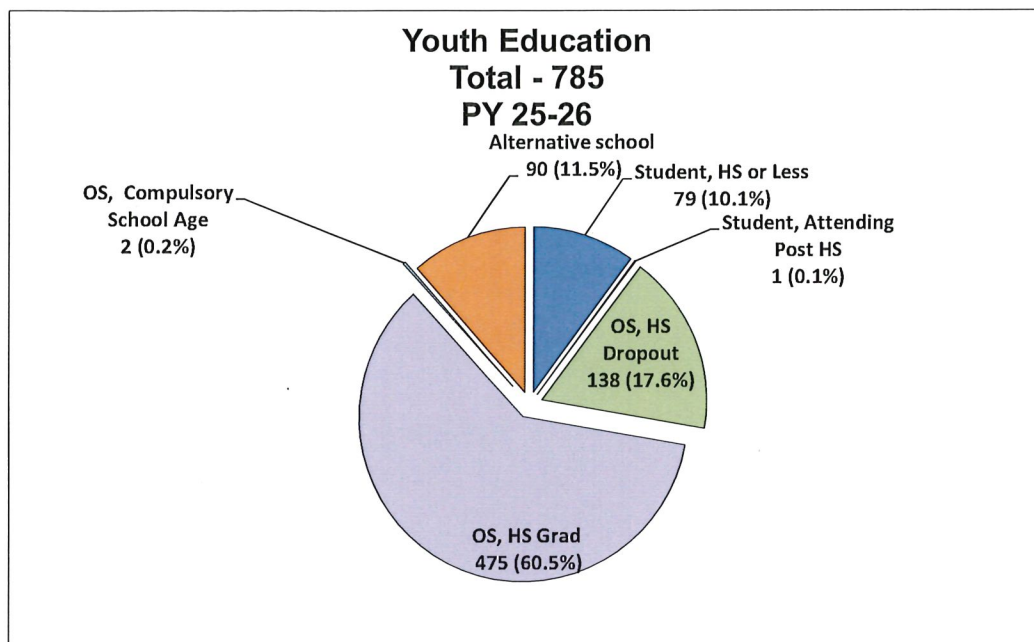
Young Adult Demographics Second Quarter, Program Year 2025-2026



Additional Assistance Barriers

1. Is at risk of dropping out of school
2. Gang Involved
3. Has experienced recent traumatic events, is a victim of abuse, or resides in an abusive environment
4. Has completed a substance abuse program
5. Poor Employment History (Older Youth ONLY)
6. Family Barriers (any one of the following):
 - a. Has a family history of long term unemployment;
 - b. During the past two years, parents/guardians have been unable to find and maintain full time stable employment;
 - c. Has a family history of long-term public assistance
7. Resides in a non-traditional family setting (any one of the following):
 - a. Being raised in a single parent household, without access to the financial and parenting support of another adult in the home;
 - b. Being raised by a guardian, relative or non-parent responsible for youth's care;
 - c. Parent is currently in jail or in prison or has been in jail or in prison for six months of the past two years
